RE-TENDER NOTICE(II CALL)

FOR DISPOSAL OF RIGHTS FOR DISPLAYING ADVERTISEMENT ON BERM SIDE OF THE ROADS /OPEN SPACES BESIDE THE ROADS AND ON ELECTRIC POLES IN VARIOUS AREAS.

The Cantonment Board invites separate sealed tenders from experience registered Firms/Contractors for the period of one year from the date of execution of Contract/Agreement for disposal of rights for displaying Advertisements on :-

1. On berm side of the Roads/Open spaces beside the roads
2. On Electric Poles in Deolali Cantonment Limits (Lam Road & Vijay Nagar, Rest Camp Road).

Earnest Money: Rs. 25000/- (Twenty Five Thousand) is to be remitted in the form of crossed Demand Draft/Bankers Cheque drawn in favour of the Chief Executive Officer, Cantonment Board, Deolali on any Nationalised / State Bank of India or its Subsidiary Banks payable at Deolali along with the tender kept in a separate envelop along with the envelope containing the Tender; both kept in a bigger envelop duly sealed. Cheques and Cash payment will not be accepted towards earnest money.

CONDITIONS

1. Interested tenderers shall submit an application for the above works for issue of blank tender form alongwith the following documents from **18-02- 2012 to 24-02-2012** during office hours. The applicant shall affix his passport size photograph in proof of his identity to the application. The application should be accompanied with a certificate certifying that the person signing the application is empowered to do so, on behalf of the Firms/Contractors. The application should be Indexed and numbered. The applicant should sign on each page.

a) An undertaking in original on Non-Judicial Govt. Stamp Paper worth Rs.100/- duly notarized stating that the Firm/Contractor etc. is not recently or in the past Blacklisted by any Govt./Semi Govt. Departments or any Public Sector Undertaking for executing any work for which the firm is registered and that the applicant/firm has not been convicted by any competent court of law in or outside India and no trial for any criminal case is pending against him/they before any competent court of law in or outside India.

b) The Firm/Contractor having capability to erect the advertisement Boards/metal frame structure and running the Contract of advertisements may participate in the tender. They should produce proof/documents showing registration for doing this business, address, PAN & TAN Card.

c) Documents showing that the Individual/Firm/Company etc has minimum one year successful experience between 2007-2011 in similar type of work carried out for other Cantonment Boards/Municipal bodies of any Govt./Semi Govt. Departments or any Public Sector Undertaking.

d) The applicant shall submit a solvency certificate of any Nationalized Bank along with the application, certifying that the financial status (Solvency) of the applicant is to the extent of Rs.5 Lakh. **The Solvency Certificate must have been issued during the year 2011. Any certificate issued prior to the year 2011 shall not be considered.**

e) **Valid Character Certificate issued by the Collector/Police Commissioner of the concerned District where the applicant ordinarily resides.**

The Solvency Certificate and Character Certificate must have been issued during the year 2011. Any certificate issued prior to the year 2011 shall not be considered.

LEVY OF LICENCE FEE FOR ERECTION OF FLEX/ADVERTISEMENT BOARDS ON TEMPORARY NATURE WITHIN CANTONMENT LIMITS ON CANTONMENT LAND AS PER SECTION 67(B) OF THE CANTONMENTS ACT, 2006.

Ref: CBR No 63 dated 04-11-2008.

As per ibid CBR, the sites for erection of Flex/Advertisement Board, rules and the rates for the same were decided. However, the same could not be implemented due to its impracticability. Therefore reconsideration of the matter is felt necessary for augmentation of revenue.

It is observed that numbers of advertisement boards have been erected in the Cantonment Area/ Road sides and on Street Light Poles without obtaining prior permission of the Cantonment Board, Deolali. It is proposed to fix the charges for flex advertisement Board in the Cantonment Area/ berm side of the roads and Street Light Poles in Deolali Cantonment limits for fixing Hoardings relating to Greetings, Social, Educational, Religious, Political, Homage, commercial and other matters which are not prohibited or offensive in nature.

The representatives of this office have carried out survey of Deolali Cantonment limits and reported that the following places can be allotted for advertisement hoardings. The details of the places and number of advertising boards/hoardings which can be fixed at the site are mentioned here under: The licences fee can be levied on advertisement hoardings other than advertisements in the newspapers as per Section 67(b) of the Cantonments Act, 2006.
